

2. To ensure the safety of DepEd personnel and the applicants, this office will follow health protocol based on the recommendation of the DOH and IATF. There will only be twenty (20) applicants per day who will be accommodated per Division Selection Committee. The list of applicants and their corresponding schedules is found in Enclosure No. 1.
3. For this year's Selection Process, this Division shall be implementing the **"One-Stop Shop" or On-the-Spot Evaluation System (OSS)** as an intervention mechanism where applicants are given the opportunity to see their ratings right after the actual interview and demonstration teaching in the Division Office. The process is stipulated in Enclosure No. 2.
4. Teacher applicant with disability will be accorded special assistance in the processing of documents to avoid unnecessary queuing and shall be accorded equal opportunity in the selection and placement process.
5. To further ensure that an effective and efficient Selection Process is in place, Division Selection Sub-Committees and Technical Working Groups have been organized to facilitate the Demonstration Teaching and the Demonstration of Skills for Specialized Training. The list is found in Enclosure No. 3.
6. All expenses that shall be incurred relative to the conduct of the activities such as meals and snacks of the DSC, the secretariat and staff, and the technical working group shall be charged against School/Division MOOE subject to the usual accounting and auditing rules and regulations.
