1. In line with DepEd Memorandum No. 194, s. 2018 entitled **Implementing Guidelines to DepEd Order No. 10, s. 2016**, this Office, through the Schools Governance and Operations Division (SGOD) will conduct a virtual Re-Orientation Workshop on the Implementing Guidelines to DepEd Order No. 10, s. 2016 on **May 26, 2021 for batch 1 (1<sup>st</sup> congressional districts) and on May 27, 2021 for batch 2 (2<sup>nd</sup> congressional districts)** via MS Teams.

4. Meals and snacks of SDO participants and other administrative costs are chargeable against SGOD Fund, while school participants to local fund or other sources subject to the usual accounting and auditing rules and procedures.




