

REGIONAL SCREENING FOR THE DEPED RO VIII POOL OF SCHOLARS BATCH 2

To: Schools Division Superintendents
Public Elementary and Secondary School Heads
All Others Concerned

1. This Office through the Human Resource Development Division (HRDD) announces the Regional Screening for the DepEd Ro VIII Pool of Scholars Batch 2 for teachers in all learning areas in the Elementary, Junior and Senior High School, non-teaching personnel, and teaching-related personnel.
2. The applicants will be evaluated based on the following qualifications:
 - a. must be a Filipino citizen;
 - b. must have rendered at least two (2) years of service in the government (DepEd) at the time of nomination;
 - c. must hold a permanent appointment at the organization nominating him/her;
 - d. must have obtained at least a Very Satisfactory performance rating for two (2) consecutive period preceding the nomination;
 - e. has sufficiently demonstrated ability and experience and initiated innovations in the area being recommended;
 - f. must have no pending administrative and/ or criminal case;
 - g. must have no pending nomination for scholarship in another program/ course;
 - h. must have already rendered the required service obligation for scholarship previously enjoyed;
 - i. must have a good command of the English Language (spoken and written);
 - j. physically and mentally fit; and
 - k. must have ICT skills.
3. The Schools Division Offices (SDOs) are expected to conduct Division Scholarship Screening of interested personnel-applicant based on the qualifications stated above and such other qualifications and requirements of the Division Scholarship Committee.



4. The SDOs must submit the following documents to Dr. Harvie D. Villamor, HRDD Chief, at hrdd.region8@deped.gov.ph with the subject POSBATCH2-(Name of Division) on or before August 30, 2021:

- a. result of the Division Screening duly signed by the Division Scholarship Committee;
- b. nomination letter of the qualified nominees using the enclosed template; and
- c. Excel file containing the name and email addresses of the qualified nominees to send the online link of the Application Form by the Regional Scholarship Coordinator.

5. The Office shall issue a separate memorandum for the final evaluation schedule of the Division nominees by the Regional Scholarship Committee.

6. Immediate dissemination of and compliance with this Memorandum are desired.
