SEMINAR ON CHILD PROTECTION POLICY AND OTHER LEGAL CONCERNS

1. DepEd Child Protection Policy through DepEd Order No. 40, s. 2012 mandates the division to promote child protection and zero tolerance policy on any act of child abuse, exploitation, or any related offenses. Thus this Office shall conduct a **"Seminar on Child Protection Policy and Other Legal Concerns" on November 21-23, 2021** at a venue to be announced at a later memorandum upon approval of the local IATF-EID.
2. After this seminar the participants are expected to be oriented and have enhanced working technical knowledge on DepEd Child Protection Policy, particularly, reporting of incidence of child bullying, child abuse, child in conflict with the law and the like.

Likewise participants are expected to become aware of and report the prohibited acts and offenses which may be committed by DepEd Personnel against a child and able to comply with the requirements mandated by the DepEd Child Protection Policy for Districts and Schools.

3. The participants of this activity shall be **thirty (30) school heads** from identified districts with the highest enrollment population based on the 2020-2021 enrollment status for DepEd Northern Samar. (*Please see attached identified Districts*). Heads of identified districts shall name school head to represent their district, and submit confirmation and vaccination details to : <https://forms.gle/5r4qi4BPGqszcaqL9> on or before **November 18, 2021**.

5. This memorandum shall serve as travel authority.
