SCHOOLS' ACADEMIC HEALTH AND MID-YEAR BREAK

1. In adherence to DepEd Memorandum DM-CI-2022-009 dated January 12, 2022 re: Reiterating the Policy on Academic Ease and Allowing Class Suspension of Classes and other Teaching-Related Activities in the Midst of the Surge in COVID-19 Cases and in consideration that the Province is in COVID Alert Level 3 Status, this Office hereby declare the Academic Health Break on January 24, 2022 up to January 28, 2022.

2. During the break, all classes, synchronous and asynchronous are suspended. A modified school calendar is provided below to complete the required number of school days.

Note: *The modification is made only in those activities within our control, schedules of activities of the Central Office based from DepEd Calendar for this school year are still in effect.*




