- 3. Participants to this Activity are the twenty four (24) District Araling Panlipuan Coordinators or District ICT Coordinators per municipality (one pax per municipality only) fourteen (14 Content and Language Editors, fiftheen (15) Layout Artists and Illustrators and six (8) Program Management Team (See Enclosure No. 1& 2)
- 4. Each participant shall bring their own laptop, extension wire, the e-copy of the crafted Travelogue of each municipality.
- Participants to this activity who travel or render services on weekends, holidays/special nonworking holidays and summer vacation can avail of the Service Credits, CTO or COC equivalent to eight (8) hours of service per day whichever is applicable per DepEd Order No. 67, s. 1988 and CSC Memo Circular No. 09, s. 1988.
- 6. No registration shall be collected from the participants. Expenses incurred of said activity but not limited to meals, snacks and materials is taken from the Division Continuing Funds. While transportation expenses of the facilitators and participants and other miscellaneous expenses relative to the conduct of this activity shall be charged against Division/School MOOE /local funds subject to the usual government accounting and auditing rules and regulations.
