1. In compliance with Regional Memorandum No. 871, s. 2023, this Office shall conduct the Division Training of Teachers and other related activities in line with the implementation of the Learning Recovery Curriculum (LRC) on the following schedules:

- 2. The Division Training of Key Stage 1 Teachers shall be a live-out activity. The participants shall look for their own overnight accommodations.
- 3. Participants of the DTOT are the following: EPS for Reading, the Regional trained facilitators and the District Trainers. Each district shall send 4 participants duly endorsed by the District Heads. The composition shall be based on the following: 1 Kindergarten teacher, 1 Grade I teacher, 1 Grade II teacher, and 1 Grade III teacher. In the case of big districts, the teachers should come from 4 different schools.



- $4. \ \mathrm{Only} \ 2 \ \mathrm{snacks}$ (morning and afternoon) and $1 \ \mathrm{lunch}$ shall be served to participants each day.
- 5. Since the LRC is in support of the National Learning Recovery Program (NLRP), expenses that shall be incurred in the conduct of the aforesaid training shall be charged against the declared excess amount of the downloaded funds per DepEd Memorandum DM-CT-2023-167 on the Guidelines on the Utilization of Support Funds for the Regional Offices for the Resources and Worksheets of End of School Year (EOSY) Reading for Grades 1 to 3 and can also be sourced out from the Support Fund for the conduct of the National Learning Camp; while travel and other incidental expenses that will be incurred by the participants relative to their attendance to this activity shall be charged against school MOOE subject to the usual accounting and auditing rules and regulations.
- 6. Attendance of all concerned is a MUST. This Memorandum serves as Travel order of the participants.

7. Immediate dissemination of and compliance to this Memorandum are desired.
