UPDATES ON THE DIVISION ROLLOUT OF FOUNDATIONAL COURSE ON ADOLESCENT HEALTH CARE FOR SECONDARY SCHOOL IMPLEMENTERS-CUM-GENDER RESPOSIVE PLANNING WORKSHOP

1. Relative to **Division Memorandum No. 060 s. 2024**, dated February 12, 2024, titled **ROLLOUT OF FOUNDATIONAL COURSE ON ADOLESCENT HEALTH CARE FOR SECONDARY SCHOOL IMPLEMENTERS**, originally scheduled to be conducted on March 22-24, 2024, to be attended by two (2) participants per Secondary School: **School Head/Gender and Development (GAD) Coordinators and Guidance Counsellors/Designate** in all Secondary Schools. Please be advised of the following updates/ changes:
 - a. The participants of the said activity will be divided into two (2) batches (final lists of participants will be posted on a separate issuance).
 - b. The activity shall be rescheduled to **April 4-6, 2024 - First Batch and April 11-13, 2024 - Second Batch**.
2. It is reiterated that ALL ninety (90) Secondary Schools including two (2) Stand-Alone Senior High School shall send two (2) participants as stated on the previous memorandum. Therefore, total of 184 participants are expected to attend.
3. Moreover, it is emphasized that the Registration Fee of **4,200.00** is per secondary school (for the two participants in each school). In case payment of the said amount was done per head (e.g. 8,400 for two participants per school), it is advised that the school send two additional participants to maximize the amount paid, since the payment is non-refundable. For registration and payment instructions please refer to DO Memo No. 060 s. 2024.
4. All other provisions of the previous Memorandum remain in force and in effect.
5. Immediate dissemination of and compliance with this Memorandum are desired.
