- Pursuant to Republic Act No. 7079, also known as the Campus Journalism Act of 1991, and in adherence to the issuance of DepEd Order No, 003, s. 2024 which formally announced the schedule of the 2024 National Schools Press Conference on July 9-13, 2024, this Schools Division hereby announces the conduct of the 2024 Division Schools Press Conference on April 11-13, 2024 at Pambujan I Central School and Pambujan National High School, Pambujan I District, Pambujan, N. Samar, with the theme, "Aligning Campus Journalism with the MATATAG agenda: Breaking Down Barriers of Isolation, Indifference, and Mediocrity; Building Up Support for Inclusion, Collaboration, and Excellence".
- The conference aims to:
 - a. Demonstrate understanding of journalism through skillful execution in various platforms (i.e. print, broadcast, online);
 - b. Recognize the role of journalism in advocating for social consciousness and environmental awareness;
 - c. Promote fair and ethical use of media as tenets of responsible journalism;
 - d. Foster camaraderie and enrich learning experiences through healthy and friendly competitions; and,
 - e. Provide learners opportunities to use the skills learned in campus journalism for their future careers.
- The participants of this activity are the pupil and student-writers, school paper advisers/coaches, district heads, education program supervisors, members of the Technical Working Group and board of judges.
- 4 The 2024 DSPC activities shall include the following:
 - a. Individual Contests (English and Filipino, Elementary and Secondary)

b. Group Contests

- i. Radio Scriptwriting and Broadcasting (English and Filipino, elementary and secondary)
- ii. Collaborative Desktop Publishing (English and Filipino, elementary and secondary)
- iii. Online Publishing (English and Filipino, secondary only)
- iv. TV Scriptwriting and Broadcasting (English and Filipino, secondary only)
- 5. The NSPC Contest Guidelines for individual and group contests shall be the basis in judging the different contest categories in the 2024 DSPC.
- 6. A campus journalist can participate in only one (1) event, either in an individual or group category, and all learners at the elementary and secondary levels (both junior and senior) from public and private schools are eligible to join the DSPC.
- 7. The top five (5) winners in all contest events to include the school paper category shall be recognized; however, only the top one (1) or first place winner in every contest category shall represent the Division to the 2024 Regional Schools Press Conference (RSPC).
- 8. All participating schools are directed to present a copy of their school paper to be presented by the contestants during the contest proper which shall then be collated by the contest facilitator or TWG.
- 9. Classes that will be affected due to the participation of the learners and advisers and those of the host schools shall be subject to alternative delivery mode or modular approach. Moreover, District Heads and School Heads should provide all learner-contestants who are attending the DSPC due recognition in accordance with the applicable DepEd policy on awards and assessment to make up for class performance, projects, assignments, quizzes, and other requirements that the participants have missed.
- 10. Since this is a face-to-face activity, parental consent shall be obtained for all student/learner-contestants to be secured by advisers or delegation heads. Said document shall be submitted to the TWG during the Solidarity Conference immediately after the Opening Program.
- 11. There shall be a preregistration link to be accomplished by all participants through https://bit.ly/Pre-registrationformDSPC2024 on or before April 10, 2024. The responses will determine the basis of contest materials, classrooms as billeting areas, contest facilitators, and other logistical preparations.
- 12. A registration fee of One Hundred Pesos (P100.00) for school paper advisers and seventy-five pesos (P75.00) for student-writers shall be paid in advance, preferably on or before April 10, 2024, by the participating schools through the DepEd Northern Samar

Schools Division's Cashier's Office to defray the expenses in the conduct of the DSPC (See attached Registration Form). The registration fee, travelling expenses and other incidental expenses that shall be incurred by the participants relative to this activity shall be charged against school MOOE/local funds, subject to the usual accounting and auditing rules and regulations.

- 13. A planning conference shall be conducted on April 5, 2024, 9:00 AM at the Catarman I CS Covered Court, to be participated by the district head of Pambujan 1 District, school heads of Pambujan Central Elementary School and Pambujan National High School, officers of Northern Samar Elementary School Paper Advisers Association (NSESPAA) and Northern Samar Secondary School Paper Advisers Association (NSSSPAA), one (1) secondary journalism adviser from public and private secondary schools, and one (1) district journalism coordinator representative.
- 14. All delegations are encouraged to wear their respective Press Nortehanon T-shirts or school uniform during the parade slated on April 11, 2024 at 7:00 AM, assembly area at the Kamagsangkay Sports Complex, Pambujan, N. Samar. The opening program shall follow immediately.
- 15. Beddings and provisions for food shall be prepared by all participants/delegations for the duration of the activity.
- 16. Attached are the Matrix of Activities, Registration Form, List of Officers of NSESPAA and NSSSPAA, and Program Management Team/Technical Working Group.
- 17. Teaching and non-teaching personnel as participants to this activity who travel or render services on Saturday and a Holiday can avail of the Service Credits, CTO or COC equivalent to eight (8) hours of service per day whichever is applicable per DepEd Order No. 67, s. 1988 and CSC Memo Circular No. 09, s. 1988.
- 18. This Memorandum shall serve as Travel Order of the TWG and Program Management Team.

19. Immediate dissemination of and compliance with this Memorandum are desired.
