- 1. - 6. Expenses incurred relative to the conduct of the activity such as travel and other incidental expenses of the participants, shall be charged to the School MOOE/ Local Fund, subject to the usual accounting and auditing rules and regulations.

UTILIZATION AND ADMINISTRATION OF THE NEWLY-DEVELOPED PHIL-IRI MATERIALS FOR HIGH SCHOOL

To: Schools Division Superintendents

All Others Concerned

- 1. In view of the recently-concluded **Workshop on Designing Effective Reading Assessments in Support of the National Reading Program (NRP)** held on September 16-19, 2024, this Office, announces that a complete set of leveled reading texts from Grades 7-12 which was patterned after the Phil-IRI for elementary is now ready for utilization and administration.
- 2. Since the hard copies of the texts and administration guidelines are yet to be printed, the schools divisions, through the Division English and Filipino Supervisors shall be given access to the drive where the materials may be downloaded or shared with the schools so they can prepare and administer the test.
- 3. The administration schedule for the High School Phil-IRI Pretest, which follows the test administration for the elementary this September, shall run from October 7 to November 22, 2024 and shall be administered to all high school students from Grades 7-12 regardless of their reading abilities in order to establish a regional baseline data on reading performance at the high school level. The administration schedule for the posttest, however, shall be the same with the dates indicated for the elementary.
- 4. The administration of the individual reading texts shall be done during the English, Filipino, and NRP class periods and shall be scheduled ahead to ensure a smooth conduct of the activity.
- 5. With the exception of the Group Screening Test which is not applicable in a test-all context, the procedure, standards, and results interpretation shall follow the existing elementary Phil-IRI guidelines on the individually-administered reading texts.
- 6. In view of this, a regional orientation to be attended by the CID chiefs, all regional and division supervisors, and members of the development team shall be conducted on September 30, 2024, Monday (1:00 P.M.) thru Google Meet (https://meet.google.com/scz-twrs-dve).


