1. Pursuant to DepEd Order No. 040, s. 2012 titled *DepEd Child Protection Policy* and in line with the initiative to strengthen the Child Protection Policy mechanisms in schools, this Schools Division, through the Schools Governance and Operations Division – Gender and Development (GAD) and Learner Rights and Protection Office (LRPO), shall conduct the **Training-Workshop on the School-based Localized Child Protection Policy** on November 12-15, 2024 at a venue to be announced in a subsequent memorandum.

2. This activity aims to:

- articulate the key elements of the DepEd Child Protection Policy and related policies on Anti-Bullying, and how these can be localized to address specific issues within their school communities;
- develop and draft a localized child protection policy that includes clear procedures for implementation, monitoring, and evaluation, ensuring compliance with both national and local standards; and
- demonstrate a commitment to fostering a safe, supportive, and child-friendly school environment, actively promoting the principles of child protection and continuous improvement in their roles as educators and school leaders.
