# TRAINING-WORKSHOP ON THE SCHOOL-BASED LOCALIZED CHILD PROTECTION POLICY

- 1. Pursuant to DepEd Order No. 040, s. 2012 titled *DepEd Child Protection Policy* and in line with the initiative to strengthen the Child Protection Policy mechanisms in schools, this Schools Division, through the Schools Governance and Operations Division Gender and Development (GAD) and Learner Rights and Protection Office (LRPO), shall conduct the **Training-Workshop on the School-based Localized Child Protection Policy** on November 12-15, 2024 at a venue to be announced in a subsequent memorandum.
- 2. This activity aims to:
  - a. articulate the key elements of the DepEd Child Protection Policy and related policies on Anti-Bullying, and how these can be localized to address specific issues within their school communities;
  - b. develop and draft a localized child protection policy that includes clear procedures for implementation, monitoring, and evaluation, ensuring compliance with both national and local standards; and
  - c. demonstrate a commitment to fostering a safe, supportive, and child-friendly school environment, actively promoting the principles of child protection and continuous improvement in their roles as educators and school leaders.
- 3. The participants of this activity are the 46 District GAD Focal Persons and 46 District Child Protection Focal Persons.
- 4. Participants are advised to bring their own laptop and extension cord for the series of workshop.

- 6. Each participant shall register at the Cashier Section and pay the amount of **5,400.00** (inclusive of meals, venue rental, accommodation, and training kits) to be charged against the 2024 School Gender and Development (GAD) Fund.
