1. In alignment with the Department of Education's commitment to improving Science Education, this Division, through the Curriculum Implementation Division, will be conducting a Training on Enhancing the Basic Science Process Skills and Content Knowledge of Grades 3 to 6 Teachers on **December 6-8, 2024**, at Ciriaco Hotel, Calbayog City.
2. The training aims to:
  - a. demonstrate mastery of the Basic Science Concepts as per Grades 3 to 6 Curriculum;
  - b. perform Basic Science Process Skills in conducting experiments and hands-on-activities related to these concepts; and
  - c. design lesson plans integrating these concepts using the Active Learning Model.
3. There will be **FIVE** participants from each district, (**District Head, 1 School Head and 3 Master Teachers**). **School Heads and Master Teachers** who previously attended the SOLO Framework Training in Tacloban are required to participate in this training to ensure alignment and continuity of learning.
4. Participants who travel or render service on weekends or holidays may avail of service credits, compensatory time off (CTO), or compensatory overtime credit(COC) as per DepEd Order No. 67, s. 1998, and CSC Memo Circular No.09,s.1998.
5. Expenses incurred relative to the conduct of the activity such as meals and snacks, board and lodging, materials, travel and other incidental expenses of
