DEPED FLAGSHIP PROGRAMS FOR FISCAL YEAR 2024**

1. This Office, through the School Governance and Operations Division – School Health Section (SGOD-SHS), shall conduct a three (3)-day live-in seminar for the conduct of the Year-End Program Implementation Review on School-Based Feeding Program (SBFP) and other Oplan Kalusugan (OK) sa DepEd Flagship Programs for Fiscal Year 2024 on December 10-12, 2024. The final venue for this activity shall be announced on a separate issuance.
2. This activity aims to:
 - a. assess the implementation of the School-Based Feeding Program (SBFP) and other OK sa DepEd flagship programs in each district/ municipality through presentation of Accomplishment Reports by district/ school nurses and other concerned School Health personnel.
 - b. provide avenue to discuss and address issues/ concerns/ problems encountered during the actual implementation of all OK sa DepEd programs with the goal of arriving in a tailored and acceptable solutions to address the identified issues.
 - c. strengthen partnership with stakeholders/ partner organizations in delivering health services/ programs among learners and school personnel.
 - d. discuss other issues and concerns that is related in the delivery of School Health programs.
3. The activity shall be attended/ participated by ALL SCHOOL HEALTH PERSONNEL, including those assigned in Autonomous Schools or those under School-Based Plantilla.
4. All expenses relative to the conduct of this activity such as meals, venue and accommodation, shall be charged against the **SBFP Program Support Fund**
