In accordance with the DepEd Memorandum (DM)-OUOPS-2025-00442, relative to the conduct of the **Learner Government Elections for School Year (S.Y) 2025-2026**, this Office informs the field for the conduct of **Supreme Elementary Learner Government (SELG) and Supreme Secondary Learner Government (SSLG) Elections**.
2. The SELG and SSLG elections are pivotal in fostering leadership skills and empowering learners to actively participate in school governance. These elections are not only to provide learners with opportunities to assume leadership roles but also highlight the significance of learner-led clubs and organizations in promoting a vibrant school culture.
3. Aligned with the preparations for School Year (S.Y) 2025-2026, the elections for the SELG and SSLG shall be conducted with the following schedule:

4. Further, this Office informs the field that there will be a District Level elections to minimize the number of participants in the conduct of Division Level elections, to which the following schedule shall be adhered to:

5. Elected SELG, and SSLG Presidents in the school-based elections shall be the representative of the said schools to participate in the District Level Elections. They shall be accompanied by their SELG/SSLG advisers. The elected District SELG, and SSLG Presidents shall be provided with a Certification that indeed,
