2. The activity aims to:
  - a. Provide opportunities for learners and public and private elementary and secondary schools, as well as those from the Alternative Learning System (ALS), Indigenous People Education (IPed), Special Needs Education Program (Send), and Madrasah Education Program (MEP) to demonstrate their best product, services, and performances as authentic pieces of evidence of their learning across academic areas, key stages, inclusion, and special curricular programs;
  - b. Instill in the minds of the learner-participants and teacher-coaches an atmosphere of sound competitions, camaraderie, and sportsmanship.
3. Only District first-place winners for Elementary and first-place winners for Secondary, shall compete in the Division Festival of Talents. The specific guidelines for every contest-category, members of the Technical Working Group, Matrix of Schedule of Activities are hereto attached. (See Enclosures)
4. District Heads and/or Delegation Heads are directed to coordinate with the School Heads of Catarman I Central School and Catarman NHS being the billeting area of all participants of the DFOT.
5. A registration fee of Php. 100.00 per student-contestant and Php. 200.00 per teacher-coach, transportation, meals and uniform shirts, shall be collected and chargeable against School MOOE/Local Funds to defray the expenses for contest equipment, materials and supplies such as certificates, program and invitation, ink and other incidental and operational expenses.
