REGIONAL MEMORANDUM

No. **074** s. 2025

2025 REGIONAL SCHOOLS PRESS CONFERENCE

To: Schools Division Superintendents
All Others Concerned

1. Pursuant to Republic Act No. 7079, also known as the Campus Journalism Act of 1991, which provides basis for the conduct of activities that promote campus journalism as a means of strengthening ethical values, encouraging critical and creative thinking, and developing moral character and personal discipline of the Filipino youth, this Office, through the Curriculum and Learning Management Division (CLMD), will hold the **2025 Regional Schools Press Conference (RSPC) on February 7-11, 2025, in Borongan City.**
2. This year's RSPC which will be hosted by the Division of Borongan City and the City of Borongan shall be anchored on the theme: **2025 RSPC - Chronicling the nation's odyssey; Nurturing the Filipino legacy.**
3. The regional activity aims to realize the following objectives:
 - a. identify the winning campus journalists and school paper advisers who shall represent the Region during the 2025 National Schools Press Conference (NSPC);
 - b. select the Most Outstanding School Paper Advisers and Most Outstanding Campus Journalists in Elementary and High School;
 - c. demonstrate understanding of journalism through skillful execution in various platforms;
 - d. recognize the role of journalism in advocating for social consciousness and environmental awareness;
 - e. promote fair and ethical use of media as tenets of responsible journalism;
 - f. foster camaraderie and enrich learning experiences through healthy and friendly competitions; and
 - g. provide learners opportunities to use the skills learned in campus journalism for their future careers.
4. Following the format of the 2025 NSPC Guidelines and some updated contest mechanics shared during the consultative meeting with the NSPC National Technical Working Group (NTWG) on October 21-25, 2024 in Quezon City, the eligible contestants of the regional competition shall be the Rank 1 Division Winners and School Paper Advisers of any event in the Individual and Group Contests in both Elementary and High School Levels as well as English and Filipino Categories. In the

event that there is a tie in the declared winners from the Schools Divisions, the concerned division is required to break the tie to ensure that each division will have the same number of entries in the contests. In terms of the number of coaches who can participate, all contestants and groups shall only have one official coach, except TV Broadcasting which can have a maximum of two coaches per team.

5. The Top 5 Winners in the regional contests shall be recognized and awarded. However, only the group champion or Rank 1 campus journalists and their coaches in the RSPC shall advance to or qualify for the 2025 NSPC while only the Top 3 Winning Campus Journalists and Teams shall receive medals. Should the identified winner/entry cannot participate in the national contest, the schools division where the contestant comes from must inform the Regional Office early so that the next in rank can be identified to represent the Region.

6. In addition to the contestants and their coaches, other participants who are required to join the conference are the members of the RSPC Program Management Team (PMT) composed of the Regional Officials and Personnel; the RSPC Team of the Division of Borongan City being the Host Division including the contest facilitators and the composite support teams assigned at the different billeting schools and activity/contest venues; Officials and Personnel of the Schools Division Offices (SDOs) which consist of the Schools Division Superintendents, Assistant Schools Division Superintendents, CID and SGOD Chiefs, Division Journalism Coordinators, Division Finance Officers and Medical Teams; Presidents of the Division School Paper Advisers Association; Officers of the Eastern Visayas Association of School Paper Advisers (EVASPA), Inc.; Resource Speakers; Contest Judges, and Proctors.

7. The conference shall have two main categories of competition:

a. Individual Contests (English and Filipino; elementary and secondary)

- News Writing
- Features Writing
- Editorial Writing
- Sports Writing
- Copyreading and Headline Writing
- Science and Technology Writing
- Photojournalism
- Editorial Cartooning
- Column Writing

b. Group Contests

- Radio Scriptwriting and Broadcasting (English and Filipino; elementary and secondary)
- TV Scriptwriting and Broadcasting (English and Filipino; secondary only)
- Collaborative Desktop Publishing (English and Filipino; elementary and secondary)
- Online Publishing (English and Filipino; secondary only)

8. Aside from the official journalism contests, there shall also be other activities which include the following:

- a. Parade;
 - b. Opening Program;
 - c. Welcome Night/Mayor's Night;
 - d. Search for the Most Outstanding School Paper Advisers and Most Outstanding Campus Journalists (Elementary and Secondary);
 - e. Concurrent Journalism Sessions;
 - f. EVASPA, Inc. Regional Meeting; and
 - g. Closing and Awarding Ceremonies.
9. As a basic requirement for admission to the contests, the contestant or team must have a copy of the school paper (pdf or digital format), school ID, and Parental Consent Form upon registration at the designated venue. Schools must also adhere to the **No School Paper, No Contest Policy** since the same is also expected during the NSPC.
10. The guidelines on contest administration and criteria for judging that will be observed in the different contests shall be based on the standards of the 2025 NSPC. However, modifications may be made by the RSPC PMT in favor of latest instructions from the NSPC-TWG or due to limitations in resources and unforeseen circumstances.
11. Contestants in photojournalism and group contests shall bring their own gadgets and equipment like cameras, memory cards, laptops, flash drives, printers, mobile broadband devices, and extension wires. Some of these equipment (cameras and laptops) shall be inspected, cleared of prohibited documents, and deposited at a designated area for safekeeping a day before the contest.
12. A registration fee of **Eight Hundred Thirty Pesos (Php 830.00)** for campus journalists and **Eight Hundred Sixty Pesos (Php 860.00)** for coaches shall be collected by the EVASPA, Inc. to finance the regional activity. The said registration fee may be charged against the school's Campus Journalism/School Paper Fund, MOOE, Special Education Fund (SEF), Division/School Local Funds, or other sources of funds, subject to the applicable accounting and auditing rules and regulations, to defray the cost of meals/snacks of all members of the RSPC PMT/TWG; rental of venue and equipment; payment for utilities and transport service; honoraria of contest judges, speakers, proctors, and members of special technical working groups; uniform/t-shirt of the members of the RSPC PMT, Host Division PMT/TWG, and SDO Officials; and other incidental, necessary expenses that will be incurred during the conduct of the RSPC.
13. Since the registration does not cover the meals of the division delegation, each Division is advised to take care of its own food provisions. The Division may seek assistance from the Host Division through the Division Campus Journalism Supervisors as to arrangements on their chosen service providers.
14. In terms of board and lodging, contestants and coaches who will stay in billeting schools are advised to bring their own sleeping bags, pillows, and blankets. On the other hand, the Host Division is requested to reserve accommodations for the select members of the PMT headed by the Regional Director, Assistant Regional Director, and CLMD Chief; heads of delegations such as the Schools Divisions Superintendents, Assistant Schools Division Superintendents, CID Chiefs, SGOD Chiefs, and Division Campus Journalism Supervisors of the 13 SDOs; contest

judges; CLMD Personnel; EVASPA Officers; and guests upon confirmation of their attendance.

15. Travel expenses of the RSPC PMT Members from the Regional Office may be charged against the Campus Journalism Fund downloaded to the Region and/or Local Funds while those of the Division personnel and teachers shall be charged to their respective local funds/MOOE or other applicable sources of funds, subject to the existing accounting and auditing rules and regulations.

16. In order to determine the expected number of participants which is necessary in the preparation of the corresponding billeting rooms, conference/contest materials attendance forms, RSPC IDs with QR codes, and official receipts; each division shall do a pre-registration using a template which shall be shared with the Division Journalism Supervisors. This template shall become the basis in coming up a list of **Individual and Group Confirmation Sheets** bearing the names of the contestants and coaches in their respective contest categories. Likewise, the Division shall submit a scanned copy of the **Summary of Confirmed Division Participants** following the template in Enclosure A which must be endorsed by the Schools Division Superintendent to the Regional Office on or before February 3, 2025. These documents shall be **final**, and the Division Office shall be made accountable to cover any financial obligation that may arise should the number of actual registrants be less than the number of pre-registered participants. To facilitate a smooth registration, payment from each division which corresponds to the number of registrants should be deposited into the account of EVASPA not later than the date stipulated above.

17. Students who are attending the RSPC as contestants or who participate in an official capacity, should be given recognition by their schools in accordance with the applicable DepEd policy on awards and assessment and should be considered to make up for the full points of the examinations, projects, assignments, quizzes, and other requirements that they might miss.

18. Students and coaches are expected to stay at their designated areas (billeting schools and contest venues) for the duration of the activity and should refrain from getting out except if they have secured permission from their delegation head. For contestants and coaches who decide to stay in a place other than those prescribed above, the students are required to submit a waiver signed by the parents/guardians while the coach must seek prior permission thru a letter request approved by the Division delegation head. To enhance security, participants should travel in groups and adopt a "buddy system" where each one is not left alone or remains unaccompanied for an extended period of time.

19. The Schools Division Superintendents should see to it that classes left by school paper advisers or coaches and teachers who assist the conduct of the event are taken over by substitute teachers, merged with other classes, rescheduled for makeup classes, or given an alternative instruction so that the schools remain on track of providing uninterrupted quality education to the students. Likewise, schools hosting the event shall make catch up plans to ensure that they can still cover targets despite their involvement in the RSPC.

20. The Officers of the EVASPA are advised to meet a day before the activity to do the necessary preparations and stay one day after its culmination, if needed, to

conduct a debriefing and make an accounting of all pertinent documents. Likewise, the RSPC PMT, Members of the Contest Administration Committee composed of Contest Coordinators, Contest Proctors, and Contest Facilitators; Contest Judges; and other support personnel shall also meet on the afternoon of February 7, 2025 at the RSPC PMT-TWG Headquarters at the Eastern Samar National Comprehensive High School (ESNCHS) for an orientation on the conduct of the contests.

21. Since the duration of the RSPC also falls on a weekend and extend beyond the 8-hour regular working period, teachers and personnel are eligible to earn compensatory time-off (CTO), overtime credit, or service credit in accordance with DepEd Order No. 53 s. 2003 or the Updated Guidelines on Grant of Vacation Service Credits to Teachers and DBM-CSC Joint Circular No. 2, s. 2015 or the Policies and Guidelines on Overtime Service and Overtime Pay for Government Employees.

22. Other important details on the RSPC such as the Terms of Reference for the RSPC PMT, Matrix of Activities, and List of Billeting Schools and Contest Venues shall be announced in a separate memorandum.

23. Immediate dissemination of and compliance with this Memorandum are desired.

**ADDENDUM TO REGIONAL MEMORANDUM No. 017, s. 2025 re: SCHEDULE OF
THE 2025 REGIONAL FESTIVAL OF TALENTS (RFOT) AND REGIONAL
SCHOOLS PRESS CONFERENCE (RSPC)**

To: Schools Division Superintendents
All Others Concerned

1. In reference with Regional Memorandum No. 017, s. 2025, re: 2025 Regional Festival of Talents (RFOT) and Regional School Press Conference (RSPC), this Office, through the Curriculum and Learning Management Division (CLMD), hereby issues an addendum to supplement the terms outlined in the aforesaid Memorandum.
2. The theme for the 2025 RFOT is ***“Soaring Futures: Honing Talents, Celebrating Skills”***.
3. A Registration Fee of **Php500.00** in cash or check shall be collected per contestant and coach to augment the downloaded funds from the DepEd Central Office which may be charged to the Division/School Local Funds/MOOE, Special Education Fund (SEF), or other eligible sources of funds, subject to the applicable accounting and auditing rules and regulations.
4. The said registration fee shall be deposited to **DEPED- BORONGAN CITY DIVISION** with account Number **0-01483-720-Development Bank of the Philippines** on or before February 7, 2025.
5. The registration fee does not cover the meals of the division delegation; thus, each division shall provide their own food/meals and may seek assistance from the Host Division as to the arrangements for potential service provider.
6. The Division Festival of Talents Focal Person is the only one authorized to register online the official participants to the 2025 RFOT at **<https://tinyurl.com/2025RFOT-Pre-Registration>** on or before January 31, 2025 so that the same can provide reference to the number of delegations per division to be billeted. The certificate of participation, recognition, and appearance shall be prepared by the host division.
7. There shall only be one Travel Order per division duly approved by the Schools Division Superintendent (SDS) during the attendance of the aforesaid activity. In case of replacement of participants, there shall also be an official endorsement duly signed by the SDS or any authorized signatory a week before the contest.

8. All contestants are advised to secure their parents'/guardians' consent and bring their own materials, ingredients, and other things needed for their assigned contest category based from the contextualized contest guidelines. Their outputs shall be brought home after the contest.
9. The contestants and coaches who will stay in the billeting schools are advised also to bring their own beddings/sleeping gears (e.g. pillows, blankets, etc.). The host division, however, will provide the cots and accommodations for the RTWG headed by the Regional Director, Assistant Regional Director, and CLMD Chief, head of delegation such as the Schools Divisions Superintendent, Assistant Schools Division Superintendent, CID and SGOD Chiefs, Division Education Program Supervisors of the 13 SDOs, contest judges, and guests upon confirmation of their attendance.
10. The contestants who participate in an official capacity, should be given recognition by their schools in accordance with the applicable DepEd policy on awards and assessment and should be given consideration to make up for the full points of the projects, assignments, quizzes, and other requirements that they missed.
11. The participants to this activity who travel or render services on days that fall on weekends and holidays can avail of the Service Credits, CTO or COC equivalent to eight (8) hours of service per day whichever is applicable per DepEd Order No. 67, s.1988 and CSC Memo Circular No. 09, s. 1988.
12. Travel and incidental expenses of the RTWG Members from the Regional Office may also be charged against the Program Support Fund downloaded to the Region and/or MOOE/Local Funds while those of the Division personnel and teachers shall be charged to their respective local funds/MOOE or other applicable sources of funds, subject to the existing accounting and auditing rules and regulations.
13. The 2025 RFOT contextualized contest guidelines, logo, list of billeting schools, activity matrix with the contest venues, Do's and Don'ts, and Working Committees with Terms of Reference shall be issued in a separate Memorandum. However, parental consent and the template for the confirmed division participants to the 2025 RFOT are found in the enclosures.
14. Immediate dissemination of and compliance with this Memorandum are desired.
