1. In compliance with DepEd Memorandum No. 024, s. 2025, this Office, through the School Management Monitoring and Evaluation (SMME) section, will administer the **National Achievement Test for Grade 6 (NATG6)** for school year 2024-2025 on **April 1, 2025**.
2. The **NATG6** will be administered on a paper-based modality to all grade 6 learners, public schools, and private schools operating with permits.
3. Relative to this, the SMME section will conduct a **virtual orientation** for public and private elementary school heads on test administration on March 25, 2025. The meeting link will be sent in a separate advisory.


