**I. SDO Pool of Learning Facilitators for Screening**


- a. *participants must bring the following: 3 printed copies of Session Guide, Slide Deck, laptop, extension cord, and portable speaker (for those who will use music)*

- d. *you may use PERSONALLY CRAFTED Session Guide from the previous training/s you have facilitated*

**II. NEAP RO8 Pool of Learning Facilitators for Certification**

- a. *a folder containing authenticated MOVs (Memorandum, Certificate of Recognition, and Training/Activity Matrix)*

2. The Screening Committee will ensure that all SDO Pool of Learning Facilitators are screened on **March 18, 2025**. All LFs must be present on that day. Should the screening not be completed, the remaining facilitators will be screened on **March 19, 2025**.

3. For reference, attached are the Screening Committee and the updated lists of SDO Pool of Learning Facilitators (Batches 2021, 2023, and 2025) to undergo Phases 2 and 3 of the screening process (Facilitation Skills Demonstration and Behavioral Events Interview) and NEAP RO8 Pool of Learning Facilitators for certification.
4. Expenses incurred relative to the conduct of this activity, such as meals of the program management team/technical working group, shall be charged against the 2024 Division MOOE (SGOD GASS), while travel and other incidental expenses of the participants shall be charged against their local funds/MOOE, subject to the usual accounting and auditing rules and regulations.
