- b. Ensure that teachers are provided with and/or adequate information, technical and legal assistance during the performance of their duties as members of the Electoral Board;
- c. Serve as DepEd institutional link to volunteer organizations and individuals.
- d. Provide close horizontal and vertical coordination and consultation among DepEd, COMELEC and partner agencies involved in the 2025 National and Local Elections; and
- e. Complement the other government agencies' efforts for an honest, orderly, and peaceful election.
- 4. The Division ETF will ensure that teachers shall be provided with adequate information, and technical and legal assistance during the performance of their duties as members of the Election Board, as well as DepEd non-teaching personnel who will serve during May 12, 2025, National and Local Elections.
- 5. The Division Election Task Force (DETF) Operation and Monitoring Center shall be established at the Division Office Building, DepEd Northern Samar Division, Mabini St, Acacia, Catarman, Northern Samar.
- 6. The Operation and Monitoring Center shall serve as DepEd institutional link to volunteer organizations, individuals, as well as partner agencies involved in the conduct of the 2025 Local and National Elections.
- 7. All DepEd Division, district, and school personnel, being in the civil service, are reminded not to intervene directly or indirectly in any election campaign or engage in any partisan political activity, except to vote.
- 8. The grant of honoraria to officials and personnel who will render services to their respective ETFs shall be subject to existing COA rules and regulations and relative to the DBM issuance on the matter.

9. Immediate dissemination of and compliance with this Memorandum are desired.
