

1. In view of Division Memorandum No. 120, s. 2025 re: Division Implementation of the 2025 Department of Education Summer Programs, this Office, through the Curriculum Implementation Division, announces the conduct of the Division Training of Teachers on the Implementation of Literacy Remediation Program (LRP) on May 14-16, 2025 at a venue to be announced in a separate issuance.
2. The activity aims to capacitate volunteer teachers and school leaders in the implementation of Literacy Remediation Program and provide all volunteers the requisite knowledge, skills and competencies in implementing the program.
3. Participants to this activity are the 264 teachers whose schools have identified low emerging learners among incoming Grade 4 pupils for SY 2025-2026. 200 volunteer-teachers shall be accommodated by this Division and the remaining 64 teachers to be absorbed by Leyte Division, same date at a venue to be determined by the latter Division.
4. The cost of meals, snacks and accommodation shall be charged to the 2025 Basic Education Curriculum Funds to be downloaded by DepEd Central Office; whereas, Travelling Expenses to school MOOE/local funds subject to the usual accounting and auditing rules and regulations.
5. This Memorandum serves as the Authority to Travel of the volunteer-teacher participants.
6. Immediate dissemination of and compliance with this Memorandum are desired.
