1. With the mandate of curriculum development, enrichment and localization and an objective to develop programs and strategize to localize, indigenize and contextualized competencies in the curriculum and to encourage learning innovation, this Office, through the Curriculum and Implementation Division – Learning Resources Management Section (CID-LRMS), announces to the field the submission of quality assured contextualized learning resources across subject areas and grade level as well ALS.
2. The developed learning resources must be needs based, curriculum compliant and contextualized to effect improved learning outcomes among our learners.
3. *All developed learning resources in any form, the Learning Resource Coordinator (LRC) of the school will collect and turn-over to the Learning Resource Coordinator of the district and forward it to the District Quality Assurance Team (DQAT) to undergo quality assurance. The PSDSs/PICs will*

review before submitting it to the Education Program Supervisor of the subject area or to LRMS office for final quality assurance. Hard and soft copy should be submitted. (ref: DM No. 008 s. 2022 dated 11 Jan 2022)

5. The conduct of quality assurance should adhere to the established Guidelines and Processes for LRMS Production and Development using the Evaluating Rating Sheet suited for the developed learning resources and a field testing should be conducted also using the Pilot Testing Instrument.
6. The quarterly submission of the developed learning resources will commence this school year 2025-2026 every mid -week of the preceding quarter and thereafter.
7. Immediate dissemination of and strict compliance with this is highly desired.
