

**FINALIZATION OF ILLUSTRATIONS, LAY-OUT AND PRINTING
OF SELECTED STORYBOOKS**

1. This Office, through the Curriculum Implementation Division – Learning Resources Management Section (CID-LRMS), will conduct the finalization of illustrations, lay-out and printing of selected storybooks developed in the previous workshops, on July 24-26, 2025 at Balay Padi, Sitio Alisyao, Brgy. Makiwalo, Mondragon, Northern Samar.
2. The selected illustrators are required to bring the following: final version of the storybook assigned to them, laptop, graphic tablet, extension wire, and any other devices that will aid them in the completion of their outputs.
3. This is a 3-day live-in activity. Attendees shall be entitled to a Service Credit/Compensatory Time Off (CTO) for the services rendered during weekends or holiday.
4. Training materials, board and lodging shall be charged to BEC Fund while travel expenses shall be charged against School MOOE/Local Funds subject to the usual accounting and auditing rules and regulations.
5. The first meal to be served will be dinner on 23 (Wednesday), July 2025 – Day O, while the last meal will be PM snacks of 26 (Saturday), July 2025.
6. This Memorandum serves as the **Authority to Travel** for all participants. (See Enclosure No. 1 for the list of participants).
7. Immediate dissemination of and strict compliance with this Memorandum is highly desired.
